Our limousine service abides by the zero tolerance program for all Illinois High Schools. We endorse and enforce this program to the fullest. We do not allow smoking in the limousine. We do not allow any alcohol in the limousine. We do not allow any drugs including prescriptions in the limousine. For simplicity, backpacks, bottles etc are not allowed. The limousine driver's function is transportation, not supervision. Supervision is the responsibility of the signed parent (signed parent assumes all responsibilities). If any of the above rules are broken, or any unruly conduct occurs, the function is ended and the signed parent will be called to pick up the young adults, otherwise by law we must notify the local police.

This contract is designed for the peace of mind for all parties.

A 20% deposit is required and payment in full, cash only, paid at the pickup.
